



## SAFETY MEASURES BEING TAKEN

I look forward to the day that the State gives me the okay to reopen my doors, in the meantime I have been very busy during “Shelter at Home” getting ready. This included taking three separate courses with a focus on COVID19 to provide a clean and SAFE working environment to protect my clients, myself and others.

The following safety precautions are being taken to protect your health and well-being as well as mine, my co-workers and others.

All of the staff at Jon Edward's Salon & Spa have been told not to work if they are sick. My temperature will be taken twice daily. I will be self-screening at home before going to work, including taking temperature &/or symptom checking using CDC guidelines.

I will be contacting all my clients prior to their visit to confirm appointments & ask if they are exhibiting any symptoms, have been sick or whether they have been exposed to someone who has been sick. If any question is answered with a yes I will be rescheduling the appointment at least 10 – 14 days out.

I have purchased BioSurf that kills germs, viruses, pathogens in 50 seconds. I will be cleaning/sanitizing & disinfecting all surfaces between each appointment.

All supplies that are not one-time-use disposables will be disinfected using an EPA-registered approved disinfectant according to directions.

All linens, towels, headbands, gowns and aprons will be deposited in a covered laundry container after each use. (Laundering includes immersion in water of at least 160 degrees Fahrenheit for at least 25 minutes.) All cleaned items are stored in an enclosed clean cabinet.

I will be wearing a mask that covers my nose & mouth. It will be discarded or washed at the end of each day.

My Personal Protective Equipment (PPE) includes a face shield, apron and gloves. (Removed, for laundering, disinfecting or discarding after each appointment.) Gloves will be used when needed & changed when needed to avoid contamination. **\* WEARING GLOVES IS NOT A SUBSTITUTE FOR REGULAR HAND WASHING! \***

**\* WEARING A SHIELD REDUCES VIRAL EXPOSURE BY 96% WHEN WORN WITHIN 18" OF A COUGH! (When worn using the recommended distancing protocol of 6 feet, inhaled viruses was reduced by 92%.) \***

I will be washing my hands frequently, (for at least 20 seconds) to include before & after seeing every client or immediately after any time I have to adjust my face coverings.

Hand Sanitizer (with at least 60% ethanol or 70% isopropanol) & kleenex tissues will also be available to clients in my facial room.

I will be allowing more time between clients to properly clean & disinfect after each appointment, to stagger appointments keeping social distance from others and to limit the amount of patrons within the business.

Hands free checkout is desired. Payment can be made through Venmo. If point of sale equipment is used it will be disinfected before & after each use.

It is preferred that clients store their next appointment on their phone to avoid the exchange of a paper reminder card.

A plexiglas barrier has been installed at the front desk & hand sanitizer will be available to make transactions safe when purchasing products in the reception area.

Wherever possible, doors will be left open to avoid touching handles.

Thorough & frequent cleaning/disinfecting with Clorox cleaner will be done in high-contact common areas such as the reception area & bathrooms. There are no touch paper towel, soap dispensers & garbage cans in bathrooms.

I will be using an air purifier with a HEPA filters that reduces up to 99.97% of harmful germs, dust, pollen, pet dander, mold spores, and other allergens. UV (Ultra Violet) light to destroy microorganisms, virus, bacteria and dust. It removes or destroys up to 99% of all surface and airborne contaminants. It kills airborne viruses such as influenza, Staph, rhinovirus, MRSA, E coli, Strep and other virus. Titanium dioxide to reduce volatile organic compounds. Charcoal filter to eliminate odors. (It also traps allergens, dust, other large particles.) An indication light lets me know when filters need to be changed so the air you breathe, will always be clean and healthy. This unit protects air and surfaces 24 hours a day! **\*The risk is low in contracting COVID when you are in a well ventilated room with few people. (Experts recommend increasing air flow to lower infection risk.)\***

The Salon is practicing social distance by limiting the amount of people in the Salon at a time. There will be proper signage to help direct you. There will be no waiting area with refreshments, magazines, books or product testers or break room for staff and will remain closed until these recommendations have been lifted by the State. To protect the staff at Jon Edwards Salon & Spa, other clients and myself..it is asked if you are exhibiting any symptoms of COVID19, please cancel your appointment. Thank you, your corporation is much appreciated.
